building on the success of the Jewish Annotated New Testament JANT and the Jewish Study Bible JSB Oxford University Press now proceeds to complete the trilogy with the Jewish Annotated Apocrypha JAA the books of the apocrypha were virtually all composed by Jewish writers in the Second Temple period excluded from the Hebrew Bible these works were preserved by Christians yet no complete standalone edition of these works has been produced in English with an emphasis on Jewish tradition or with an educated Jewish audience in mind the JAA meets this need the JAA differs from prior editions of the apocrypha in a number of ways first as befits a Jewish annotated apocrypha the volume excludes certain texts that are widely agreed to be of Christian origin second it expands the scope of the volume to include Jubilees an essential text for understanding ancient Judaism and a book that merits inclusion in the volume by virtue of the fact that it was long considered part of the canon of the Ethiopian Orthodox Church the text is also revered by Ethiopian Jews third it has restructured the order of the books so that the sequencing follows the logic that governs the order of the books in the Jewish canon law history prophecy wisdom and poetry using the NRSV translation plus Jubilees each book of the apocrypha is annotated by a recognized expert in the study of ancient Judaism an introduction by the editors guides readers through the making of the volume and its contents thematic essays by an impressive array of scholars provide helpful contexts backgrounds and elaborations on key themes

Beare Award this engaging and accessible textbook provides an introduction to the study of ancient Jewish and Christian women in their Hellenistic and Roman contexts this is the first textbook dedicated to introducing women's religious roles in Judaism and Christianity in a way that is accessible to undergraduates from all disciplines the textbook provides brief contextualising overviews that then allow

for deeper explorations of specific topics in women's religion including leadership domestic ritual women as readers and writers of scripture and as innovators in their traditions using select examples from ancient sources the textbook provides teachers and students with the raw tools to begin their own exploration of ancient religion an introductory chapter provides an outline of common hermeneutics or lenses through which scholars approach the texts and artefacts of judaism and christianity in antiquity the textbook also features a glossary of key terms a list of further readings and discussion questions for each topic and activities for classroom use in short the book is designed to be a complete classroom ready toolbox for teachers who may have never taught this subject as well as for those already familiar with it jewish and christian women in the ancient mediterranean is intended for use in undergraduate classrooms its target audience undergraduate students and their instructors although masters students may also find the book useful in addition the book is accessible and lively enough that religious communities study groups and interested laypersons could employ the book for their own education

students in seminary or graduate theology programs learn that some books in the bible are anonymous their professors will make the point that many pauline letters have disputed authorship and may in fact not be written by paul students will also learn about the practice of pseudonymity in the world of the bible and how some gospels or letters are written under a false name now for those who become pastors or church leaders what are they to do with what they learn do they teach their congregants about these authorship questions do they ignore that part of their training as irrelevant to the task do they avoid teaching or reading publicly from disputed books do these questions not matter in the end because the church settled on the canon this book aims to address these pastoral challenges an international group of scholars from universities seminaries and graduate theology programs convened to discuss these matters at the lanier theological library in may 2022 these essays represent how many faculty are wrestling with the pastoral implications of anonymity and pseudonymity in the new testament

the atonement deception explores the christian theological fiction that belief in jesus is the only way to receive divine forgiveness for ones sins biblically both jews and gentiles can receive forgiveness of sins through sincere repentant confessional prayer directed to the god of israel this is true at all times and in all places there has never been a need for the so called intercession role jesus is supposed to play in attaining atonement the facts speak for themselves there is no truth to the christian contention that jesus died for our sins and salvation is only through jesus jesus death does not bring atonement from sin nor is it in any way a fulfillment of biblical prophecy

women in the gospel of mark provides a literary analysis of every passage dealing with women in mark this analysis is placed against a first century understanding of women to show how both the author and a first century audience create the characterization of women from how the narrative is told

paul s doctrine of election has remained a controversial and enigmatic topic for centuries few studies however have approached paul s doctrine through the context of second temple judaism this study examines paul s view of election through the lens of second temple jewish texts written

prior to 70 ce in doing so it is argued that the best framework through which to view paul's discussion of election is through a primarily corporate model of election while such a model is rooted in judaism paul departs from his jewish contemporaries in arguing that the locus of election is in god's messiah jesus

this book makes a major contribution to the ongoing debate about the synoptic problem especially concerning the question of which gospel was written first the scholarly consensus developed over two hundred years of discussion has favoured markan priority and the dependence of both matthew and luke upon mark in an ongoing contemporary revival of the griesbach hypothesis some scholars have advocated the view that mark used conflated and abbreviated matthew and luke the author explores the role played by arguments connected with christological development in support of both these views deploying a comparative redaction critical approach to the problem dr head argues that the critical basis of the standard christological argument for markan priority is insecure and based on anachronistic scholarly concerns nevertheless in a thorough going comparative reappraisal of the christological outlooks of matthew and mark the author finds decisive support for the hypothesis of markan priority arguing that matthew was a developer rather than a corrector of mark

in the gospel of john the character of jesus repeatedly comes into conflict with a group pejoratively designated as the jews in chapter 8 of the gospel this conflict could be said to reach a head with jesus labeling the jews as children of the devil 8 44 a verse often cited as epitomizing early christian anti judaism using methods derived from modern and post modern literary criticism ruth sheridan examines textual allusions to the biblical figures of cain and abraham in john 8 1 59 she pays particular attention to how these allusions give shape to the gospel's alleged and infamous anti judaism exemplified in john 8 44 moreover the book uniquely studies the subsequent reception in the patristic and rabbinic literature not only of john 8 but also of the figures of cain and abraham it shows how these figures are linked in christian and jewish imagination in the formative centuries in which the two religions came into definition

this work examines the background of the ethiopian eunuch in acts 8 26 40 for a comprehensive study it utilizes echoic allusion cultural background and narrative criticism it explores the textual tradition of deut 23 1 8 in jewish literature with a particular focus on isaiah s inclusive presentation of eunuchs and foreigners in contrast to the deuteronomy stipulation for the assembly of the lord this work also explores the ancient practice of castration the jewish exiles in elephantine and jewish pilgrimage to reconstruct the cultural background of the ethiopian eunuch additionally it focuses on luke s authorial role in presenting the gospel s geographic ethnic and religious expansion to identify the ethiopian s ethnic and religious identity in the narrative development of the three trajectories the conclusion drawn is that the ethiopian eunuch cannot be identified as an uncircumcised gentile instead he is more like an african man of jewish descent included in the abrahamic covenant but excluded from the cultic setting of worship in the temple
